SPEKKO™– Competition Terms and Conditions/Rules

1. **Application:** Please read the competition terms and conditions (“**Terms**”) carefully. These Terms apply to everyone entering the SPEKKO™ 2024 7 Days 7 Ways 7 Week Competition (“**the Competition**”).
2. **The Promoter:** This Competition is conducted by Pioneer Foods (Pty) Limited, situated Parc Du Cap Office Park, Building 5, 10 Willie van Schoor Avenue, Bellville, 7530 (“the Promoter”).
3. **Terms:** Instructions on how to enter the Competition, the rules, directions and prizes all form part of these Terms. If you take part in this Competition, you agree to be bound by these Terms and accept that the Promoter’s decision is final.
4. **Competition Period:** The Competition will start on 28 October 2024 at 00:01 and will end on 16 December 2024 at 23:59.
5. **Eligibility:** The Competition is open to all citizens and legal residents of South Africa. You must reside in South Africa at the time of winning or becoming eligible to receive any prize in the Competition. You must be 18 (eighteen) years or older to enter this Competition and have a valid identity document, or a valid passport, and valid residency permission (if applicable).
6. **People who may not enter the Competition:** Any person who is a director, contractor employee or can be considered a member of staff of, of the Promoter and its affiliated and related entities (“Associates”) and immediate family members of Associates, and the Promoter’s advertising agencies or service providers involved in the delivery of the (“Disqualified Persons”).
7. **How to Enter:** To enter, you must purchase any Spekko product and scan the QR code on the promotional material instore and on television. Consumer will need to share their Spekko inspired meals. All entries will need to have a Spekko pack next to their inspired meal.
8. **Winner Selection:**
 - (a) Entries will be entered into a draw and each week, for the duration of the Competition, 7 winners will be selected to win R7000 in cash. In total, 49 winners, each winning R7000 will be selected.
 - (b) Unless the Consumer Protection Act (Act 68 of 2008) specifies differently, the decision is final.
 - (c) Cash prize winners will be notified via telephone within one week of the draw. The Promoter will endeavour to contact the prize winners on the telephone number provided. If, however, they cannot be reached after 6 attempts have been made during business hours within a period of 72 hours for any reason whatsoever, the prize will be forfeited, and another winner will be selected in accordance with the competition rules.
 - (d) Cash Winner Prize Payment: All winners will be contacted and will be required to present their valid identity document or passport, till slip under which the Spekko™ product was bought, verified bank account letter and sign an indemnity form (if required). Cash payments will be made via bank transfer within 1 week of successful winner verification.

- (e) Unless the Consumer Protection Act (Act 68 of 2008) or any similar, applicable legislation, specifies differently, the judge's decision is final.
9. **Prizes:**
- (a) Entrants stand a chance to win their share of R343 000 in total cash prizes weekly.
 - i. Seven (7) x R7,000 cash winner will be drawn at the end of the each week via a technology enabled draw tool.
 - ii. Valid entries with a visible Spekko Inspired meal and with a Spekko pack on the image will stand a chance to be in the draws.
 - (b) You may not ask for your prize to be exchanged for another prize.
10. **Winner Verification and Prize Delivery:** The prize is not transferable. The Promoter expressly allow a maximum period of 30 days from date that a winner is identified for the completion of all requirements detailed hereunder for the identified winner to comply with and receive the benefit of the prize to include availability to the Promoter of the till slip, identification documentation and in the case of case prizes validated bank details for the individual identified. 12. **Defects:** The Promoter is not responsible for defects in the prizes. The Promoter's total aggregate liability to you will not exceed the financial value of the prize as detailed hereunder.

Vouchers are non-refundable and cannot be exchanged for cash. The Promoter is not responsible for the loss, damage, or misuse of the voucher.
